- 5. Contribute to planning a range of programs and activities for school age youth according to designated core program area.
- 6. Utilize area management techniques to gain control of program space and ensure members are fully engaged.

- 7. Communicate clear and simple instructions to members before each program and activity to ensure that members understand rules, expectations, and directions.
- 8. Provide positive feedback, encouragement, and recognition for members to highlight achievements.
- 9. Contribute to developing positive relationships with parents & families.
- 10. Follow program schedule to ensure area management

## **ADDITIONAL RESPONSIBILITIES:**

May participate in special programs and/or events. Complete other job duties as assigned.

## **RELATIONSHIPS:**

**Internal:** Maintains close, daily contact with Club staff (professional and volunteer), Club members, and supervisor to receive/provide information, discuss issues, explain guidelines/ instructions; instruct; and advise/counsel.

**External:** Maintains contact with external community groups, schools, members' parents and others to assist in resolving problems.
